The Discourse of Islam in Populism Movement

Keywords: ChatGPT, Islamic Populism, Islamic, Populism This article aims to examine the discourse of Islam within the Islamic populism movement. The study of Islamic populism continues to receive attention in recent years. With remarkable developments, this article aims to explore the concept of Islamic populism within ChatGPT as a human intelligence platform that has been formatted into a technological program. This study is a qualitative research using a literature review approach. All data comes from the text-based ChatGPT, resulting from systematically formulated questions input on January 9th, 2023. Findings from ChatGPT's readings on Islamic populism provide information that the movement lacks a single meaning and definition. Islamic populism adapts to religious issues and sentiments, depending on the context in which it develops.

1. Introduction

The study of Islamic populism in recent years has become a widely discussed topic among scholars (Muhtadi & Muslim, 2021; Staley, 2021). Hoelzl's, (2020) study depicts that previous studies on populism and religion tend to only focus on negative relations, so positive relations between populism and religion are marginalized (Hoelzl, 2020).

There are three clusters of keywords commonly used in discussions of Islamic populism. The first cluster, when discussing Islamic populism, the dominant keyword used is "Indonesia". In this keyword, studies on Islamic populism also use other keywords such as politics, Muslim middle class, power, democracy, Middle East, and Islamic politics. The second cluster, the dominant keyword used in discussions of Islamic populism is "Islamic Populism". In this keyword, there are other keywords such as movement, populism, and women. The third cluster, the




Figure 1. Keyword study of Islamic Populism. Analisis VOSviewer, (2023)

dominant keyword in discussions of Islamic populism is "Islam". In this keyword, other keywords used are identity politics, role, religion, society, interest, and Afghanistan. Associations from the three clusters can be seen in the VOSviewer visualization in Figure 1.




Figure 2. Graphic Study of Islamic Populism. Output Dimensions.ai, (2023) Keyword "Islamic Populism"

Additionally, based on the dimensions.ai database using the keyword "Islamic Populism" with identification based on "title and abstract," there are 73 studies that discuss Islamic populism and have experienced significant growth in recent years, as depicted in Figure 2.




Figure 3. Co-Authorship Analysis of Islamic Populism. Output Dimensions.ai, (2023) kata kunci "Islamic Populism"

The data above shows that studies on Islamic populism have experienced very significant growth. In the dimensions ai database, 63 scholars who wrote about populism between 2015 and 2003 were found. The 63 authors can be seen in Figure 3.

The works of the 63 authors on Islamic populism above are published in various publication media or journals such as the Philosophy and Religious Studies Journal, Human Society Journal, History Heritage and Archaeology Journal, Language Communication and Culture Journal, Creative Arts and Writing Journal, Education Journal, and Law and Legal Studies Journal.




Figure 4. Category Study of Islamic Populism. Output Dimensions.ai, (2023) Keyword "Islamic Populism"

Based on the database above, this article aims to examine how "Islam" is utilized as a discourse by the populist movement in rallying the masses on the artificial intelligence platform named ChatGPT. Populism in Islam is a variant form of populism in general (Hadiz, 2018; Zuquete, 2017). As part of populism, Islamic populism also incorporates various aspects of

interests (Barton, Yilmaz, & Morieson, 2021; Juoro, 2019), aspirations, and complaints from a specific social class, particularly the marginalized Muslim community (Wijanarko, 2021) from both the political and economic systems (Hadiz, 2019). From a class approach, Hadiz (2019) in his work "Islamic Populism in Indonesia and the Middle East" explains that Islamic populism is defined as an alliance between dominant and subordinate classes (Hadiz, 2019; Watson, 2017). The alliance between classes is united by the narrative of "shared fate" (Putra, 2019). Hadiz, (2019) refers to it as the "cultural resource pool" that is available to create political language as a bond between different classes (Hadiz, 2019). Islamic populism shares similarities with populism in the mobilization and homogenization of diverse dissatisfaction of the masses against the elite. The difference lies in the basis and icons. Populism has a more diverse basis compared to Islamic populism compared to old-fashioned populism that is rooted in small bourgeoisie/lower-class people (Hadiz, 2021; Hadiz & Robinson, 2017). If the old-fashioned populism prioritizes the branding of "people" to unite the spirit, then Islamic populism prefers to use the branding of "ummah" in every movement. The word "ummah" is associated with a pious society facing an elite depicted as immoral and greedy (Hadiz, 2019).

The rise of Islamic populism can be attributed to a few factors. Firstly, it can be linked to the economic advancements of capitalism as a result of neoliberal globalization. Secondly, the impact of social conflict and the Cold War has impacted Islamic political and social movements, leading to the loss of left-wing and liberal political influence (Hara, 2018). The goals of Islamic populism are to seize power, mobilize the masses, and exploit resources (Peker, 2019). Its ability to seize authority over religious identity-related symbols, terminology, and imagery has allowed Islamic populism to unite vastly different groups of society that have all experienced the marginalizing effects of modernization in different degrees, although still experiencing social, political, and economic injustice (Hadiz, 2019). When feelings of marginalization, injustice, and the like exist among the "Islamic" community, why are these feelings manifested in the form of a movement? According to Hadiz (2019), in the Islamic populist movement, agents often rely on culturally based references that have meaning in specific contexts. For example, Wickham argues that the success of Islamic social agents can be attributed to their ability to adapt a respected cultural heritage for new purposes. Halliday explains that Islam has a cultural heritage of values, symbols, and ideas that can be transformed into a political system. In other words, like other major belief systems, Islam has the potential to provide a cultural resource for the expression of complaints about social conditions that may be contrary to common understanding of what is fair and good (Hadiz, 2019). According to Bayat (2013), it is for this reason that Islamic populism argues that Islam can be made democratic, despite issues that are entirely religious and scriptural in nature.

Another difference between populism and Islamic populism is the matter of zoning/region. It is important to note that zoning is not just a place of growth for populism, but rather emphasizes the aspect of religious followers who are in the majority position in each country. Globally, the rise of populism can be divided into two zones; first, the European zone (America, the Netherlands, France, Russia, Germany, and England) (Elbert, Li, Galbraith, & Saave-harnack, 2019; Kusumo & Hurriyah, 2019; Madung, 2018) and second, the Asian zone (Thailand, the Philippines, South Korea, Australia, Turkey, Egypt, and Indonesia) (Kusumo & Hurriyah, 2019; Madung, 2018).

Populism in Asia, particularly in countries with predominantly Muslim populations that often undergo significant changes in social, economic and political fields, also has its own unique trajectory (Garadian, 2017). According to Hadiz (2019) in "Islamic Populism in Indonesia and the Middle East", there are different trajectories of populism in Muslim countries such as Turkey, Egypt, and Indonesia (Luthfi, Fathy, & Asadi, 2019). In Turkey, the political trajectory of Islamic populism can be considered successful, allowing the AKP (Justice and Development Party) to occupy and control the government. In this sense, Islamic populism can coexist with democracy

and the existing government system in Turkey. It is not anti-capitalism and neoliberalism, but rather anti-morally bankrupt capitalists. The capitalism in question is characterized by the sale of alcohol, sex, or promotion of riba practices, let alone causing the social and economic backwardness of the Muslim community associated with Western colonialism. In Egypt, where they also experienced oppression, in this context, the Muslim Brotherhood was able to control civil society but failed to control the government (Budiharjo, 2019). As for the trajectory of Islamic populism in Indonesia, since the Orde Lama and entering the Orde Baru, they are said to have failed to control the government like in Turkey and have not yet been able to control civil society like in Egypt (Hadiz, 2019).

2. Method

This study is a qualitative research with a literature review approach centered on "Islamic Populism" as the central issue in the article. The data in this article originates from ChatGPT. The type of data collected in this article is text-based. ChatGPT is one of the products of technological advancements that falls under the category of Artificial Intelligence (AI) (Elkins & Chun, 2020; O'Connor, 2023) or human-made intelligence modeled into a program form (Dicoding Intern, 2020; Zhai, 2022). Data related to Islamic populism sourced from the ChatGPT platform was collected using 34 systematically arranged questions which were inputted one by one on the ChatGPT platform on January 9, 2023. The questions can be seen in the display below:

In this article, data analysis uses qualitative analysis with the Miles and Huberman (Miles & Huberman, 1994) approach and the Creswell approach (Jhon, 2015). The visualization of all the data collected through ChatGPT is displayed in the form of tabulated tables displayed in the results section of the article.

1.1 Definition of Islamic Populism

(c) Being a positive agent of change: The movement can maintain itself by continually striving to be a positive agent of change for society, such as by advocating for the rights of Muslims or restoring Islamic values in society. (d) Becoming a trusted and respected party: The movement can maintain itself by continuing to be a trusted and respected party by society, either through concrete actions or programs it holds..

1.5 Islamic Populism and Country

Islamic populism is also a movement that emphasizes traditional interpretations of Islam and aims to protect the interests of the Muslim community and promote Islamic teachings. Although there are some similarities between these two movements, there are also some differences. Islamic populism focuses more on defending the interests of the Muslim community, while Islamism focuses more on the implementation of Islamic law in political, social, and economic life. Additionally, Islamist movements are more likely to use a more radical approach in pursuing their goals, while Islamic populist movements are more likely to use a more moderate approach.

4. Discussion

The data above indicates two interpretations of the concept of Islamic populism advocated by ChatGPT. First, Islamic populism is positioned as an ideology that is pro-people's interests. Second, Islamic populism is a political ideology that emphasizes good governance. As an ideology, "Islam" in Islamic populism is more positioned as a tool to convey values that show allegiance to issues affecting the lower class such as inequality, marginalization, and social justice. In this context, the word "Islam" in populism is not conceptualized as a term containing values of kindness and moral values (Jati, 2015), but instead as a general conceptualization of populism as an ideology and political rhetoric. This interpretation is in line with Mudde's (2007) conceptualization of populism as an ideology that pits the people against corrupt elites.

While Islamic populism is a concept of political thinking, "Islam" is more positioned as a political instrument to balance state life and address various challenges of the times. In this framework, Islamic populism can be seen as political rhetoric, where it is a political discourse, talk, and claim that strengthens marginalized group issues. Thus, it can be understood that the discourse of Islamic populism is actually a force to strengthen collective identity. This is because religion (Islam) is considered so crucial in life (Lakonawa, 2013). Religion is not only a source of protection for individuals, but can also provide benefits for groups (Amri, 2017). Similarly, when discussing Islamic populism, religion is only used as an object and an instrument for mobilizing the populist movement. Religious proofs such as verses from the Quran and Hadiths are narrated as well as possible by populist actors to illustrate their commitment to the people or Muslim community. That's why ChatGPT gives a signal that the religion brought into the populist movement is only to strengthen rhetoric to attract support from the Muslim community (Hadiz, 2019; Jati, 2017b; Yusuf, Afrizal, & Alfiandi, 2022). ChatGPT finds that well-established actors often get involved in populist movements, such as people affiliated with Islamic-oriented political parties, scholars, and Islamic activists. These actors are considered as the social base that have a

license for religion, so lower class groups that are participants in the Islamic populist movement can easily believe that the populist movement is considered a movement that fights for their rights.

The relationship between Islamic populism and the state is paradoxical. On one hand, the Islamic populism movement always prioritizes Islam as the basis and pillar of the nation and state (Basya, 2019). On the other hand, not all populist movements that have developed in predominantly Islamic countries are anti-the state's existing principles. ChatGPT also explains that Islamic populism doesn't have to be in opposition to the existing state system. There have also been instances where Islam and the state system complement each other. This is due to the dynamic and contextual relationship between the state and religion, which varies depending on the political situation and conditions surrounding it (Shalihin & Hidayatullah, 2022). The same goes for Islamic populism and other religious issues such as the caliphate system, jihad, terrorism, radicalism, and Islamism. ChatGPT explains that not all Islamic populist movements can be confirmed to use such issues, but it is also not ruled out that these issues may be used by Islamic populist movements in their efforts to fight for the people (Jati, 2017).

5. Conclusion

The findings of the study show that first, the diction of Islam is used by populism as a discourse to depict the basis, ideology, and strategy of populism in mobilizing masses in predominantly Muslim countries. Attaching the word "Islam" to "Islamic populism" has made Islamic populism a paradigm in determining the issues, ideas pursued, policies demanded, accepted actors, and activities carried out.

Secondly, the discourse on Islamic populism is a very flexible, adaptive, and situational movement, depending on the context in which it grows and develops. Such a tendency makes the discourse on Islamic populism have a wide scope in determining choices that can benefit the movement. This interpretation gives the understanding that the discourse on populism is not a singular movement, but rather, it has various variations and dimensions according to the context, including social, political, economic, and religious contexts it faces.
